

前　　言

為明瞭連江縣馬祖地區家庭收支分配發展趨勢、水準變動狀況，提供縣政府作為研訂社會發展計畫，改善縣民生活，增進社會福利之參考，及提供各界研究探討連江縣馬祖地區所得、儲蓄及消費型態之分配、運用。

連江縣馬祖地區家庭收支調查始於民國七十六年，由本處辦理抽樣調查。本調查項目包括：一、家庭戶口組成，二、家庭設備及住宅概況，三、經常性收入，四、經常性支出（含非消費支出與消費支出），五、資本損益及移轉收支，調查期間於次年一月至二月進行實地訪查作業，資料經彙整檢誤後，結果編印調查報告書，供有關單位與學術機構參用。

本調查感謝抽樣訪查戶之充分合作，提供詳實資料，並承蒙行政院主計總處地方統計推展中心家庭收支科同仁，對調查方法及統計結果之分析鼎力指導，使本項計畫能於最短時間內完成編算，且內容益見確實完整，謹此併致謝忱。惟因本處人力不足，同仁學驗淺薄，雖孜訖以赴，疏漏恐所難免，尚祈各界不吝指正，俾資遵循並供嗣後改進之參考。

貳、綜合分析

II 、Summary Analysis

貳、110 年家庭收支調查結果綜合分析

家庭收支調查係按年辦理之連江縣馬祖地區家庭收支狀況，主要目的在瞭解連江縣馬祖地區家庭所得與消費之變動，俾提供政府施政方針、民間企業訂定經營策略及學術機構研究分析之依據。


110 年馬祖地區家庭收支調查係採分層隨機抽樣方法，共抽出 200 戶為本調查之樣本，其各項調查重要結果摘述如下：

一、平均每戶家庭所得收入

110 年本縣馬祖地區戶數計 3,458 戶家庭，平均每戶 2.26 人，平均每戶成年人數 1.83 人，平均每戶就業人數 1.23 人，家庭平均所得收入 119 萬 9,356 元，與 109 年的 133 萬 1,007 元相較，減少 13 萬 1,651 元(減少 9.89%)。

若按所得來源分，以受雇人員報酬 76 萬 9,863 元，占 64.19% 為最多；其後依序為經常移轉收入 19 萬 7,742 元，占 16.49%；產業主所得 14 萬 7,532 元，占 12.30%；自用住宅設算租金收入 6 萬 1,979 元，占 5.17%；財產所得收入 2 萬 1,890 元，占 1.82%；雜項收入 350 元，占 0.03%。(圖一)

平均每戶所得收入按鄉鎮別分，依序為南竿鄉為 139 萬 9,628 元；東引鄉為 109 萬 4,099 元；莒光鄉為 101 萬 1,844 元；北竿鄉為 84 萬 2,235 元。



二、每戶家庭可支配所得及儲蓄

110 年本縣家庭平均每戶可支配所得為 100 萬 3,796 元，較 109 年 110 萬 3,953 元減少 10 萬 157 元(減少 9.07%)。每戶可支配所得中位數為 82 萬 2,237 元，平均每戶儲蓄為 36 萬 9,790 元。


依平均可支配所得按戶數五等分位組觀察，最高百分之二十家庭平均每戶 212 萬 278 元，最低百分之二十家庭平均每戶 31 萬 8,352 元，高低所得差距為 6.66 倍。

平均每戶可支配所得按鄉鎮別分，依序為南竿鄉 118 萬 1,368 元；東引鄉 92 萬 6,044 元；莒光鄉 77 萬 3,070 元；北竿鄉 70 萬 5,534 元。(圖二)


每戶可支配所得中位數按鄉鎮別分，依序為南竿鄉 98 萬 6,608 元；東引鄉 90 萬 8,303 元；莒光鄉 71 萬 9,077 元；北竿鄉 64 萬 332 元。

平均每戶儲蓄按鄉鎮別分，依序為南竿鄉 45 萬 6,720 元；東引鄉 30 萬 1,453 元；北竿鄉 24 萬 9,189 元；莒光鄉 22 萬 5,185 元。(圖三)

圖三、平均每戶儲蓄 — 按鄉鎮別分




三、平均每戶家庭支出

110 年本縣平均每戶家庭支出為 82 萬 9,566 元，與 109 年的 98 萬 7,860 元相較，減少 16.02%，其中消費支出為 63 萬 4,005 元，占 76.43%；非消費支出（包括利息、社會保險保費、稅捐規費及罰款、捐贈及婚喪壽慶禮金等經常移轉支出）為 19 萬 5,561 元，占 23.57%。

於消費支出中按消費生活型態觀察，以住宅服務、水電瓦斯及其他燃料費 17 萬 2,885 元，占消費支出之 27.27% 為最高，其次依序為食品及非酒精飲料費 10 萬 6,118 元，占 16.74%；醫療保健費 9 萬 4,604 元，占 14.92%；交通費 6 萬 061 元，占 9.47%；餐廳及旅館費 5 萬 4,574 元，占 8.61%；什項消費 3 萬 5,203 元，占 5.55%；家具設備及家務維護費 2 萬 4,107 元，占 3.80%；衣著鞋襪及服飾用品費 2 萬 1,961 元，占 3.46%；通訊費 2 萬 783 元，占 3.28%；休閒與文化費 1 萬 6,427 元，占 2.59%；菸酒及檳榔費 1 萬 3,936 元，占 2.20%；教育費 1 萬 3,345 元，占 2.10%。(圖四)

平均每戶消費支出按鄉鎮別分，依序為南竿鄉 72 萬 4,648 元；東引鄉 62 萬 4,591 元；莒光鄉 54 萬 7,885 元；北竿鄉 45 萬 6,345 元。

圖四、平均每戶家庭消費支出—按消費型態別分




四、家庭現代化設備之普及率

110 年本縣自有住宅家庭戶（含戶內經常居住之成員所擁有及不住在一起之配偶、父母或子女所擁有）占全體家庭戶之 76.67% 為多數，其後依序為租賃或租押者占 14.83%，配住及借用者占 8.51%；平均每戶住宅建坪為 40.71 坪，每人可居住建坪為 18.01 坪。

就家庭各項設備普及率觀察，彩色電視機普及率達 93.39%；有線電視頻道設備（含多媒體隨選視訊）則達 79.91%。隨著電信自由化及電腦上網之普遍化，電話機普及率達 67.33%；行動電話普及率已達 95.98%；家用電腦普及率達 53.09%；連網（使用電腦及其他設備）普及率亦達 88.26%。交通設備以機車普及率 68.20% 高於汽車普及率 48.37%。（圖五）

此外，洗衣機、熱水器等一般生活必需品，均達九成以上，明顯可看出家庭現代化設備日趨普及化，縣民生活之水準與品質已提升。

五、家庭經濟戶長之行業及職業


110 年本縣家庭經濟戶長依性別分，以男性 2,208 戶為多數，女性則為 1,250 戶；每戶平均所得收入，男性為 131 萬 2,038 元，女性為 100 萬 346 元。

依行業別分，平均可支配所得以服務業之 117 萬 531 元為最高；工業為 95 萬 2,622 元次之；農業為 73 萬 615 元再次之；無業者之 44 萬 6,641 元為最低。



依職業別分，平均可支配所得以民意代表、主管及經理人員為 164 萬 4,512 元位居首位；專業人員之 146 萬 7,165 元位居第二位；技術員及助理專業人員為 137 萬 4,554 元位居第三位；其餘依序為事務支援人員 123 萬 1,683 元；服務及銷售工作人員 91 萬 4,429 元；機械設備操作及組裝人員 89 萬 9,721 元；農、林、漁、牧業生產人員 73 萬 615 元；技藝有關工作人員 69 萬 5,131 元；基層技術工及勞力工 65 萬 1,816 元及其他 48 萬 83 元。(圖七)

圖七、平均每戶平均可支配所得-按經濟戶長職業別分




六、本縣（馬祖地區）與台灣地區所得之比較


110 年本縣平均每戶所得收入為 119 萬 9,356 元，較台灣地區平均每戶所得收入 131 萬 4,023 元少 1.10 倍，其中馬祖地區以經常性移轉收入少於台灣地區 9 萬 5,647 元為最多，財產所得收入少 3 萬 5,158 元次之，而受雇人員報酬則較台灣地區多 3 萬 7,080 元（圖八）。

最終消費支出較台灣地區少 18 萬 1,437 元，但儲蓄較台灣地區多 9 萬 4,678 元。（圖九）
