

前 言

為明瞭連江縣馬祖地區家庭收支分配發展趨勢、水準變動狀況，提供縣政府作為研訂社會發展計畫，改善縣民生活，增進社會福利之參考，及提供各界研究探討連江縣馬祖地區所得、儲蓄及消費型態之分配、運用。

連江縣馬祖地區家庭收支調查始於民國七十六年，由本處辦理抽樣調查。本調查項目包括：一、家庭戶口組成，二、家庭設備及住宅概況，三、經常性收入，四、經常性支出（含非消費支出與消費支出），五、資本損益及移轉收支，調查期間於次年一月至二月進行實地訪查作業，資料經彙整檢誤後，結果編印調查報告書，供有關單位與學術機構參用。

本調查感謝抽樣訪查戶之充分合作，提供詳實資料，並承蒙行政院主計總處地方統計推展中心家庭收支科同仁，對調查方法及統計結果之分析鼎力指導，使本項計畫能於最短時間內完成編算，且內容益見確實完整，謹此併致謝忱。惟因本處人力不足，同仁學驗淺薄，雖孜孜以赴，疏漏恐所難免，尚祈各界不吝指正，俾資遵循並供嗣後改進之參考。

貳、綜合分析

II 、 Summary Analysis

貳、111 年家庭收支調查結果綜合分析

家庭收支調查係按年辦理之連江縣馬祖地區家庭收支狀況，主要目的在瞭解連江縣馬祖地區家庭所得與消費之變動，俾提供政府施政方針、民間企業訂定經營策略及學術機構研究分析之依據。


111 年馬祖地區家庭收支調查係採分層隨機抽樣方法，共抽出 200 戶為本調查之樣本，其各項調查重要結果摘述如下：

一、平均每戶家庭所得收入

111 年本縣馬祖地區戶數計 3,594 戶家庭，平均每戶 2.38 人，平均每戶成年人數 1.89 人，平均每戶就業人數 1.36 人，家庭平均所得收入 122 萬 7,750 元，與 110 年的 119 萬 9,356 元相較，增加 2 萬 8,394 元(增加 2.37%)。

若按所得來源分，以受雇人員報酬 83 萬 4,992 元，占 68.00% 為最多；其後依序為經常移轉收入 17 萬 9,341 元，占 14.61%；產業主所得 13 萬 254 元，占 10.61%；自用住宅設算租金收入 5 萬 2,293 元，占 4.26%；財產所得收入 3 萬 876 元，占 2.51%；雜項收入 64 元，占 0.01%。(圖一)

平均每戶所得收入按鄉鎮別分，依序為南竿鄉為 136 萬 9,854 元；東引鄉為 118 萬 9,026 元；北竿鄉為 100 萬 8,472 元；莒光鄉為 97 萬 5,698 元。



二、每戶家庭可支配所得及儲蓄



111 年本縣家庭平均每戶可支配所得為 103 萬 2,422 元，較 110 年 100 萬 3,796 元增加 2 萬 8,626 元(增加 2.85%)。每戶可支配所得中位數為 87 萬 7,082 元，平均每戶儲蓄為 39 萬 3,158 元。

依平均每戶可支配所得按戶數五等分位組觀察，最高百分之二十家庭平均每戶 245 萬 8,200 元，最低百分之二十家庭平均每戶 43 萬 5,388 元，高低所得差距為 5.65 倍。

平均每戶可支配所得按鄉鎮別分，依序為南竿鄉 113 萬 6,885 元；東引鄉 101 萬 7,077 元；北竿鄉 86 萬 4,312 元；莒光鄉 85 萬 1,146 元。

每戶可支配所得中位數按鄉鎮別分，依序為南竿鄉 101 萬 4,478 元；東引鄉 77 萬 5,298 元；北竿鄉 70 萬 6,255 元；莒光鄉 58 萬 3,472 元。(圖二)

平均每戶儲蓄按鄉鎮別分，依序為南竿鄉 39 萬 2,605 元；莒光鄉 47 萬 4,374 元；東引鄉 39 萬 8,260 元；北竿鄉 36 萬 1,433 元。(圖三)




三、平均每戶家庭支出

111 年本縣平均每戶家庭支出為 83 萬 4,591 元，與 110 年的 82 萬 9,566 元相較，增加 0.61%，其中消費支出為 63 萬 9,263 元，占 76.60%；非消費支出（包括利息、社會保險保費、稅捐規費及罰款、捐贈及婚喪壽慶禮金等經常移轉支出）為 19 萬 5,328 元，占 23.40%。

於消費支出中按消費生活型態觀察，以住宅服務、水電瓦斯及其他燃料費 17 萬 3,554 元，占消費支出之 27.15% 為最高，其次依序為食品及非酒精飲料費 10 萬 9,900 元，占 17.19%；醫療保健費 8 萬 2,552 元，占 12.91%；交通費 5 萬 9,187 元，占 9.26%；餐廳及旅館費 5 萬 6,390 元，占 8.82%；什項消費 4 萬 2,338 元，占 6.62%；家具設備及家務維護費 2 萬 1,983 元，占 3.44%；衣著鞋襪及服飾用品費 2 萬 3,791 元，占 3.72%；通訊費 2 萬 793 元，占 3.25%；休閒與文化費 2 萬 1,526 元，占 3.37%；菸酒及檳榔費 1 萬 5,321 元，占 2.4%；教育費 1 萬 1,928 元，占 1.87%。（圖四）

平均每戶消費支出按鄉鎮別分，依序為南竿鄉 74 萬 4,280 元；東引鄉 61 萬 8,817 元；北竿鄉 50 萬 2,879 元；莒光鄉 37 萬 6,773 元。

圖四、平均每戶家庭消費支出 — 按消費型態別分




四、家庭現代化設備之普及率

111年本縣自有住宅家庭戶占全體家庭戶之70.85%為多數，其後依序為租賃或租押者占12.95%，戶內經常居住之成員所擁有及不住在一起之配偶、父母或子女所擁有之家庭戶占12.27%，配住及借用者占3.93%；平均每戶住宅建坪為45.74坪，每人可居住建坪為19.22坪。

就家庭各項設備普及率觀察，彩色電視機普及率達95.46%；有線電視頻道設備(含多媒體隨選視訊)則達83.53%。隨著電信自由化及電腦上網之普遍化，電話機普及率達65.51%；行動電話普及率已達96.50%；家用電腦普及率達56.63%；連網(使用電腦及其他設備)普及率亦達87.91%。交通設備以機車普及率68.91%高於汽車普及率46.95%。(圖五)

此外，洗衣機、熱水器及冷暖氣機等一般生活必需品，均達九成以上，明顯可看出家庭現代化設備日趨普及化，縣民生活之水準與品質已提升。

圖五、家庭現代化設備普及率




五、家庭經濟戶長之行業及職業


111 年本縣家庭經濟戶長依性別分，以男性 2,535 戶為多數，女性則為 1,059 戶；每戶平均所得收入，男性為 129 萬 9,821 元，女性為 105 萬 5,250 元。

依行業別分，平均可支配所得以服務業之 112 萬 8,366 元為最高；工業為 111 萬 6,131 元次之；農業為 61 萬 2,444 元再次之；無業者之 46 萬 4,908 元為最低。(圖六)

依職業別分，平均可支配所得以民意代表、主管及經理人員為 158 萬 9,875 元位居首位；專業人員之 153 萬 3,038 元位居第二位；技術員及助理專業人員為 138 萬 1,821 元位居第三位；其餘依序為機械設備操作及組裝人員 126 萬 4,162 元；事務支援人員 102 萬 5,448 元；技藝有關工作人員 96 萬 9,760 元；基層技術工及勞力工 86 萬 635 元；服務及銷售工作人員 84 萬 8,370 元；農、林、漁、牧業生產人員 61 萬 2,444 元及其他 51 萬 2,099 元。(圖七)



圖七、平均每戶平均可支配所得-按經濟戶長職業別分




六、本縣（馬祖地區）與台灣地區所得之比較


111 年本縣平均每戶所得收入為 122 萬 7,750 元，較台灣地區平均每戶所得收入 134 萬 848 元少 1.09 倍，其中馬祖地區以經常性移轉收入少於台灣地區 11 萬 6,320 元為最多，財產所得收入少 3 萬 1,319 元次之，而受雇人員報酬則較台灣地區多 8 萬 7,189 元（圖八）。

最終消費支出較台灣地區少 19 萬 5,274 元，但儲蓄較台灣地區多 11 萬 9,126 元。（圖九）
